

Quail Shoot Release and Waiver of Liability

Please read carefully and sign and date below.

Your safety is our primary concern. No one may participate in any hunting or shooting activities unless this form is completed. You must follow safe gun handling and hunting procedures. No alcohol or drug consumption is allowed before or during the hunt.

We have a Zero Tolerance policy when it comes to the safety of you and your fellow hunters. Persons violating the safety rules outlined in this waiver and verbally covered during your safety course are subject to forfeiting their shooting opportunities. No refund will be provided.

RELEASE AND WAIVER OF LIABILITY

By my signature below, I certify that I am fully aware of the hazards involved in the sport of hunting and understand the necessary actions to assure hunter safety. I am also aware of the hazards associated with a farm and/or ranching operation. In consideration of being permitted to participate in the sport of shooting conducted by Quail Covey Run, LLC., I am willing to assume these hazards and do recognize they can be dangerous to both life and limb.

In full recognition of such, I hereby release, waive and discharge Quail Covey Run, LLC., its owners, employees, or people with whom they may contract for services, including all landowners, (Releases), from all liability to the undersigned, my spouse, legal representative, heirs and assigns, for any and all loss, claim or damages resulting therefrom, on account of injury to me or my property, even injury resulting in death, while participating in the sport of hunting and shooting. This release and waiver is complete as it is my intent to hold harmless and indemnify Releases for any injury that might result while I am involved in the sport of hunting or shooting conducted by Quail Covey Run, LLC. while on its premises.

The undersigned assumes full responsibility for the risk of bodily injury, death or property damage due to the actions or inactions of Releases. The undersigned agrees this release, waiver and indemnification agreement is intended to be as broad and inclusive as permitted by the laws of the State of Texas.

At Quail Covey Run, we value fun just as much as safety. So be ready for some great flying quail, laughs, heckles, cheers all within a respectively controlled shooting arena! The following rules have been established for your safety and the safety of others. Please read through the list below. Safety regulations will also be covered by a facilitator prior to the shoot.

QUAIL SHOOT RULES

- Do not shoot outside of the designated shooting arena boundaries
- Do not shoot quail that land on the ground
- Do not climb fences or touch fencing that has electrical current
- Pick up all trash and hulls and dispose of them in the provided receptacles
- Be aware of other participant's locations and do not shoot towards them
- Treat every gun as if it is loaded. Either point the barrel to the ground or directly to the sky.
- Only one shooter is allowed on the shooting platform at a time. All other participants may
 watch from the observation platform or directly behind the shooter at a distance of 30 ft.
- All shotguns must be racked in the space provided near the shooting platform. No shotguns are allowed on the observation platform.
- Only two shotgun shells can be loaded/chambered for each quail target.
- All shooters must have a valid Texas hunting license with upland gamebird endorsement
- Follow the State of Texas and US Federal migratory bird hunting laws! Wear eye & ear protection
